

# Request for Extension of Time to Earn Eagle Scout Rank



This form is only for the current COVID-19 (Corona Virus) situation.

The BSA National Advancement Team has announced a temporary advancement policy change during the current COVID-19 emergency. This temporary change is in effect until December 31, 2020 (date subject to change by the National BSA). Three Harbors Council will be authorized to directly grant time extensions to Life Scouts who believe that they will be prevented from completing their Eagle Scout rank requirements before their 18th birthday by the COVID-19 disruptions. These extensions are granted for a three-month period.

You will be notified that your request has been received and will be reviewed as soon as possible. You will be notified by email of the disposition of your request. If approved, the extension approval notification you received must be attached to your Eagle Scout Rank Application form when it is submitted for your board of review.

All applicants will need to complete Youth Protection Training (YPT) prior to submitting extension request. Certificate of completion needs to be attached with request. It is a requirement of National that scouts are required to register as adults when they turn 18, this will allow them to continue their work on the Eagle rank requirements. **NOTE: Failure to complete this requirement could result in this extension being revoked.**
